The Mission of the Pro-Life Legal Fund

Since 1986, our organization has effectively advanced the interests of the pro-life movement in court cases and advocated for pro-life public policies at the local, state, and national levels. Our continuing efforts include protecting pro-life sidewalk counseling, protecting the medically vulnerable, resisting transgender tyranny, requiring abortion chambers to comply with child abuse reporting laws, protecting existing and passing new pro-life legislation in Pennsylvania.



Resisting the Pennsylvania Abortion Industry's Routine Cover-Up of Sexual Assaults on Girls

To his credit, Pa. Attorney General Dave Sunday, in March 2025, commenced defending Pa.'s Medicaid abortion funding restrictions from a 2019 lawsuit filed by 16 Pa. abortion chambers.



However, he is currently declining to use his law enforcement status to have the Pa. Department of Health report the number of abortions, by County, being committed on girls aged 12 and under. Our organization is leading efforts to obtain this information to advance efforts to have Pa. abortion chambers lose their license for not reporting the sexual assaults against these girls.

Defeating Three Pro-Abortion Pennsylvania Supreme Court Justices



The Democrat Majority Pa. Supreme Court is considering voiding Pa.'s life-saving Medicaid abortion funding restrictions in response to a lawsuit brought by 16 Pa. abortion chambers after Democrats achieved a majority on the Pa. Supreme Court. The November 4, 2025 General Election provides an opportunity to remove three pro-abortion Democrats on the

Pa. Supreme Court by defeating them in a Retention Vote. Our organization is serving in the leadership of efforts to achieve their defeat.

New Resistance to Transgender Ideology

Our organization has previously provided leadership in educational and court efforts to resist this ideology. We are now serving in the leadership of legislative efforts to resist this ideology by preventing male participation in female sports. We are specifically urging the Pa. House to pass S.B.9, Save Women's Sports Act, which has already passed the Pa. Senate. If passed, Gov. Josh Shapiro is likely to veto this legislation and, thus, again reveal that he is no "moderate" as he seeks re-election in 2026, and possibly run for President in 2028.
